NOTICE TO EXHIBITORS

*The safety of the dogs is the primary concern so by entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

*Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.

*It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.

*Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

*Exhibitors are responsible for complete, accurate, and legible information on the entry forms. Any illegible or incomplete entries will not be entered in the trial.

Directions to the Show Site

From the South:

On HWY 35 go north to exit #249 (Boundary Avenue). Turn Left. Follow Boundary Ave about 3.6 miles all the way until it ends at the South St. Louis County Fairgrounds on your right. Dirt Floor Arena is the last building on your left. Parking is available on three sides of the building.

From Wisconsin:

Take HWY 35 south of Duluth and exit at #250 onto Highway 2. Travel north ½ mile to Boundary Avenue. Turn Right and follow road about 2.5 miles all the way until it ends at the South St. Louis County Fairgrounds on your right. Dirt Floor Arena is the last building on your left.

Parking is available on three sides of the building.

From the Iron Range;

Highway 53 to Midway Road in Pike Lake, Turn Right going south following Midway Road to Highway 2. Turn left and follow in to Proctor. Turn left onto Boundary Avenue and follow road about 2.5 miles all the way until it ends at the South St. Louis County Fairgrounds on your right. Dirt Floor Arena is the last building on your left.

Parking is available on three sides of the building.

!!!! On the entry form, “DD” stands for “Double Down”.

Double Down (DD) is offered for Snooker (Friday), Colors (Saturday), and Wildcard (Sunday). Double Down allows a re-run of the Round 1 course. There is no additional walk-through, and the course will remain the same. The fee is the same as the first round.

There will be one walk-through for both rounds: Walk – Run – Run (i.e. walk level 35C, run round 1 of 35C, immediately followed by round 2 of 35C – then walk level 1/2, immediately followed by round 2 of level 1/2. !!!
